**PROGRAMMATIC, FISCAL, AND REPORTING ASSURANCES**

The United States Department of Education (USED) has approved the application from the State of Alabama for ESSER funds under the CARES Act. The availability of funds is from 4/29/2020 to 4/29/2021. **How will the LEA determine the most important educational needs as a result of COVID-19?**

Tuscaloosa City Schools will determine its most educational needs using results from the Situational Appraisal (SCAN Process) and surveys which were inclusive of parents, students, businesses and all other community stakeholders. The data that is gathered from the SCAN will be used to develop short-term educational goals that will have a long-term impact on student achievement. A diverse team will analyze the district needs results, rate the data, and develop an action plan that will benefit all of the students in Tuscaloosa City Schools impacted during the COVID pandemic. The funds will be utilized for instructional services, instructional support services, operational and maintenance, auxiliary services, and general administration.

**How does the LEA intend to assess and address student learning gaps resulting from the disruption in educational services?**

Students' learning gaps will be assessed using universal screeners, benchmark assessments, TCS data teams protocols, and evidence-based practices, using proven strategies from tiered instructions and proven response to interventions (RTI) practices.

**What is the LEA's proposed timeline for providing services and assistance to students and staff?**

Our projected timeline for providing services is March 16, 2020 - September 30, 2022. Beginning March 16, 2020, Tuscaloosa City Schools Central Support Team member aligned the curriculum goals and action plans to address the priority standards for the remainder of SY2020. June 1, 2020 instructional plans for grades PK-12 were created and embedded within the Recovery and Reopening Plans to help maximize student-learning opportunities for Summer 2020 and SY 2021. The district goals and action strategies are manageable and tied to the needs of both public and non-public school students in Tuscaloosa City.

**How will the LEA use ESSER funds to promote remote learning?**

As a priority, the district's technology plan and the literacy framework has been revised to include additional technology to promote and support remote learning. The integration of additional technology equipment and support staff for teaching and learning programs across the district has been formatted on a wide scale to affect the quality of teaching and learning for all students and communities in Tuscaloosa City.

**3. Equitable Services Assurances**

Beginning June 1, 2020, services to students and teachers in participating non-public schools were provided consultation to determine needs of students impacted by COVID-19. The data and information obtained from the private schools will be used to develop short-term educational goals that will have a long-term impact on non-public school student achievement. Based on needs and equitable services, the collaborative action plan will benefit all those that were potentially impacted by school closure and COVID related instructional opportunities for SY2021. All funds will be expended by September 30, 2022.

**4. Other Assurances and Certifications**

  - (5) that the local educational agency will provide reasonable opportunities for the participation by teachers, parents, and other interested agencies, organizations, and individuals in the planning for and operation of each program;
  - (6) that any application, evaluation, periodic program plan or report relating to each program will be made readily available to parents and other members of the general public;
  - (7) that in the case of any project involving construction -
    - (A) the project is not inconsistent with overall State plans for the construction of school facilities, and
    - (B) in developing plans for construction, due consideration will be given to excellence of architecture and design and to compliance with standards prescribed by the Secretary under section 504 of the Rehabilitation Act of 1973 in order to ensure that facilities constructed with the use of Federal funds are accessible to and usable by individuals with disabilities;
  - (8) that the local educational agency has adopted effective procedures for acquiring and disseminating to teachers and administrators participating in each program significant information from educational research, demonstrations, and similar projects, and for adopting, where appropriate, promising educational practices developed through such projects; and
  - (9) that none of the funds expended under any applicable program will be used to acquire equipment (including computer software) in any instance in which such acquisition results in a direct financial benefit to any organization representing the interests of the purchasing entity or its employees or any affiliate of such an organization.
- (c) A general application submitted under this section shall remain in effect for the duration of the program it covers. The State agencies or boards administering the programs covered by the application shall not require the submission or amendment of such application unless required by changes in Federal or State law or by other significant change in the circumstances affecting an assurance in such application.

**6. Section 427 of the General Education Provisions Act Assurances**
